I. Executive Summary

- Parish remittances are 59% of budget.
- Central Church Support from the Diocese of the West is 45% of budget.
- Stewards of the West income is 20% of budget.

II. Statement of Financial Position (Accrual Basis - Consolidated Balance Sheet)

The Consolidated Balance Sheet reflects both **unrestricted** and **restricted** fund accounts. Savings and investment account names on the detailed balance sheet report indicate the current interest rate on funds in those accounts.
